Highway Issues: Ongoing discussions on potholes, raised kerb stone near Kirkstyle.

Play Park: Phase 2 – Clerk to contact the contractors with the following queries, 1) Why was the fence taken down before the play equipment has under gone the post installation inspection? Do you have a date? 2) And more importantly – if a child is injured or has an accident is the liability with yourselves as this play equipment has not been signed of by yourselves. 3) When will the finishing off of landscaping top soil and seeding take place, apparently the area around has ruts from the vehicles. Once signed over to the Parish Council will instigate the statutory safety inspection as required.

Planning Application 18/02270/FUL: Proposed demolition of existing garage and construction of new garage and single storey rear extension - Cherry Tree Barn, U7076 Slaggyford Main Road to Greenhead Road, Slaggyford CA8 7NH - Parish Councillors have no objections to the application.

Regarding working at weekends, I will discuss the possibility with our Contract staff.
