8. Support for Epiacum Heritiage:

Request for financial support, unable to help as all monies are required for the play park. Cllr Hutchinson to get in contact re possibility of accessing Community Chest grant. The Council were pleased to hear of the plans for the Epiacum Project, which will bring tourism into the area.

13. Any Other Business:

Communal Wheelie Bins At Station (General Waste): Cllr Hutchinson to contact NCC to ascertain if it is possible for another bin, these bins serve a good number of residential dwellings.

Eals Bridge: Cllr Moore declared a personal and prejudicial interest and left the room.

Cllr Hutchinson gave an update on the work schedule and the present position. After a discussion it was agreed this is an important link within the rural parish and the parishioners are concerned that this work may not take place, the Clerk was instructed to contact NCC and request information: **Under the Freedom of Information Act** - The cost of carrying out the required work? How much additional costs have/are being incurred due to the delay in the work commencing? How much compensation (public money) is being paid to enable this vital work to be undertaken? Cllr Moore re-joined the meeting.

South Tyne Trail: Complaints have been received from walkers/dog walkers etc., regarding farmers using quad bikes (speeding) on this trail, as well as sheep roaming free. It would appear the field fences have been pulled down to allow the stock onto the trail. This trail is for cyclists and walkers, not a bridle way. Cllr Hutchinson to speak with NCC/Sustrans regarding this matter.

Footpath (Slaggyford Station): Blocked off – Cllr Hutchinson to check this out with NCC Rights of Way.
