	2. To paint a double white line of Glenwhelt Bank going east out of Greenhead. At the moment cars can overtake going down the hill and it is inappropriate and dangerous.				
	3. There is a cycle path running along Glenwhelt Bank that is not being used by walkers and cyclists who continue to use the B6318. This is obviously dangerous with traffic able to overtake. The Council would like the cycle path to be in view as well as having better signage. If the hedge running in between could be cut back, the path may be more obvious.
