Good Evening - My report on the various issues and developments that we on this council have been involved with over the past very challenging period from our year 2019/Early 2020 to our current closing period of 2020/2021

I will first give my appreciation & personal thanks to all our members present and those recently retired (Mr George Price) who have for these particularly challenging years been fully committed to their role as Parish Counsellors.

PARISH COUNCIL WEBSITE

The Parish Council Website is now under dual control with NALC 'Hosts I.T.', with our Parish Clerk having access when required to change information.

INTERNAL AUDITOR

Mr David Girdwood, Northumberland Accountants is now engaged in auditing the Parish Council Accounts.

THE CEMETERY

The Cemetery maintenance contract remains with Mr Eric Tolman, 'Complete Landscapes' as their quality workmanship plus care of the grounds is of an exceptionally high level and continues to be highly praised and recognised with appreciation relayed to the Parish Council from both residents & visitors to the cemetery.

The County Council Cemetery Grant of £10k which Acting Clerk, Councillor Hillan had successfully applied for in regard to funding the necessary repairs to the Access road, gravel paths and edging boards. All are now repaired or replaced as required. Therefore thanks are also due to DT Thompson (Ground Works)

THE HUB - Development Trust & Resource Centre

WHALE BONES

We are delighted to be able to look forward to the Whalebones being securely installed in a conspicuous & prominent southerly position overlooking the Harbour and out to Sea so that they can be fully appreciated by residents and visitors alike for many years into the future.

MAIN ST - PARKING MANAGEMENT

Changes to Village Centre Parking - Time specific NO PARKING (between 9am - 6pm) due to various hold-ups has yet to be implemented this year between the two Main St roundabouts (no exemption for Blue Badges) Date for completion unknown.

CORE STRATEGY

Expected changes in local government means the core strategy has not yet been rescinded, which may extend any planned progress for another year.

We continue to be in the position of being held to the original 'Berwick Local Plan' for the foreseeable future. However, this should be resolved within the coming year as our Neighbourhood Plan is now consolidated as a major developmental structure for our 'Partnership Parish Councils' of Seahouses, Beadnell & Bamburgh.

Jen Hall from Beadnell continues to be our area representative on the AONB & continues to be fully committed in acting on behalf of our stunning coastal area.

NORTHUMBERLAND COUNTY COUNCIL

SEAHOUSES CAR PARK - PUBLIC AMENITIES

Congratulations to all those Council & contract workers for the hard work put in to ensure them being fully completed with perfect timing for the lifting of Lockdown - the toilets are of good modern standard and now fully operational.

ROAD IMPROVEMENTS

We appreciated the extensive work completed on the 'overflow' area of the car park which has significantly increased its capacity and hope this will go some way to offset the time limited parking on the Main St.

Completion of street repairs and improvements on James St, Main St, and Southfield Ave have made a significant difference to these extremely busy routes for traffic accessing our School, Health Centre & Residential areas.

However

Our concern on behalf of our residents and tourists continues with still many dangerous areas of deterioration (main surfaces and roadside edges which are being broken by wider & heavier vehicles) to and from our A1 main access routes leading from our coastal villages, particularly our 'local route' via Swinhoe, Chathill, Preston Tower Hill which although recent works have been completed, repairs are still done as 'site specific' - with other identified pothole/very worn areas within very close vicinities being ignored - consequently necessitating many future return visits & disruptions within the same area. This piecemeal approach which has been a long standing & constant aggravation for all concerned continues!

NCC COMMUNICATION

The NCC 'county wide' communication system is showing some improvement towards local parish councils however still frustrating for us - is the way the County Council continue to apply determined pressure to shift costly responsibility onto small Parish Councils such as ours.

Furthermore; the frustration we continue to have with the County Council in regard to planning enforcement is - the perpetual situation of many years still to be recognised and resolved - of pointing out that planning enforcement is ineffectual in the face of some property owner's blatant refusal to comply & follow through with government enforcement orders. This defiant attitude of property owners refusing to abide by local laws is therefore seen as an option for others to follow thereby contravening and negating both the local and national planning regulations.

CONCLUDING THIS REPORT.

This coming term of 2021/2022 for this Parish Council will no doubt have challenges to overcome & achievements to celebrate, which, I continue to have confidence that you will ensure positive involvement and development in our local community.

I look forward to observing continued growth particularly for our Parish of North Sunderland and Seahouses and also through the Neighbourhood Plan initiative with our neighbours Bamburgh & Beadnell continuing their developed positive working practices,

We, as representatives for our community, have come to the completion of another year of being a part of our Parish Council and this point has always brought for me a strong sense of belonging & satisfaction which I would always recommend to others who may consider joining the NSPC.

I strongly feel that it is with channelling & giving freely of our enthusiasm, expertise & talents as proactive members within, and for, our community, that promotes those uplifting feelings and sentiments.
