MINUTES OF PARISH COUNCIL MEETING

Minutes of the Extraordinary General Meeting/AGM of the Rennington Parish Council meeting held at 6.45pm on Wednesday 31st May 2023 at Rennington Village Hall.

Present: Cllrs Robert Dixon (Chair), Stephen Baggott, Andy Sisson, Alan Tremlett, Katie Robertson, Peter Purdom, Phil Green, Fred Bosanquet (joined the meeting late).

The meeting opened at 6.45pm.

123/23 Election of Chair

Due to the absence of votes being taken for candidates at the AGM held on 11th May, the election was run again. Cllr Green proposed Cllr Dixon and was seconded by Cllr Dixon. Cllr Purdom proposed Cllr Baggott and Cllr Sisson seconded the motion. The voting was as follows: 3 votes for Cllr Baggott, 2 votes for Cllr Dixon, 2 abstentions.

Cllr Baggott gave a Vote of Thanks to Cllr Dixon for his achievements in Chairing the Council over the last two years which has resulted in a more adventurous and ambitious council. Cllr Baggott urged all councillors to work together to continue Cllr Dixon's work to benefit the Parish Council and the Community.
