#### **Police Report**

##### *Incidents and crimes –*

*There are no crimes of note that we can report on during the last 28 days. The number of crimes that have been recorded is extremely low. The number of incidents reported is also extremely low since your previous meeting.*

##### *Community Issues –*

*ASB: There has been reports of youth ASB occurring at the Clifftop Caravan Park, Seahouses on 14<sup>th</sup> December 2025. Youth causing issues entering the park banging on doors and throwing items at caravans. Identity of youths unknown currently. Patrols made in area. There have been no further reports of ASB occurring at the caravan park. No ASB reported elsewhere in Seahouses area.*

*No disorder reported by any local pubs*

*High visibility patrols have been conducted in the area.*

## **128/2025 MATTERS ARISING**

1. Replacement/new bus shelters – potential grant of £15k won – no further update
2. Precept/Budget for 2026/2027 – The Chair noted that over the last 4 years the cemetery had consistently run at a loss, and the reserves are now dwindling quickly. Currently have a 25% loss ytd and the precept has not previously included any budget for the cemetery. It was proposed that the costs of running the cemetery should now be budgeted for in the precept calculations. Further discussions took place regarding possible raising of additional funds from the cemetery. It was noted that on a Band D property it would be less than a £1 a month increase. Cllr Hillan proposed increasing the precept to £34,000, Cllr Trotter seconded – majority agreed (Cllr Fordy abstained)
3. Cemetery Contract – It was agreed to carry this forward to the next meeting.
4. Joint Town & Parish Council spring Conference, March 5<sup>th</sup> – The chair noted the Spring conference and the PC has 2 invitations. Any Cllrs wishing to attend should advise the Clerk.
5. Driver awareness Talk by Police – The Clerk noted that no further contact has been received from the police – the Clerk to chase again.

## **129/2025 PLANNING**

**To make comments on the following applications:**

1. **25/04338/FUL** Single-storey rear extension to hipped roof and extend front and rear dormers **4 Farne Crescent, Seahouses, NE68 7ST** – The Chair noted that there is a public right of way next to the property and it is important this is not affected. The meeting also agreed that the design & building materials should be in keeping with existing – no objection
2. **25/004270/FUL** Proposed single-storey entrance porch **3 Osborne Terrace, North Lane, Seahouses, NE68 7UH** – The meeting has no objection to this application
3. **25/04246/FUL** Single storey kitchen extension to rear and first floor dormer windows to bedrooms **Dunedin, 8 Broad Road, Seahouses, NE68 7SU** The meeting agreed that there was no objection to this application as long as it is in keeping with the surrounding area.

Potential for allowing grazing by sheep – no further update, however, Cllr Fordy noted that there may be grants available to farmers to fence the land – The Chair asked him to look into this option and report back.

Update on soil – The Chair noted the PC's thanks to Slate Hall Riding Centre for the donation of the top soil and to David Smith Builders for kindly collecting the soil and removing the clay. It was noted that the top sheet is split and a new cover may be needed – it was agreed to carry this forward to the next meeting.

### 132/2025 CORRESPONDENCE – none

**133/2025 COUNTY COUNCILLORS REPORT** – Cllr Renner-Thompson reported that the graffiti that was on the roundabout had been reported to the police, and the person suspected had been given a caution. The mini roundabout had now been repaired, and the pole has been removed as agreed.

It was also noted that NCC are facing a challenge financially as the additional money from the central Gov is only £12m over the next 3 years.

The additional survey for the football club has now been completed and it is hoped that planning permission will now follow. It was also noted that a generous benefactor had offered to pay for the new clubhouse. Cllr Renner-Thompson is also currently helping the church with their application for a new heating system.

Cllr Shiel asked if the section 137 money promised from the Shoreside Hall development had been received? Cllr Renner-Thompson thought nothing had been finalised yet as new planning had to

be sought. Cllr Fordy also raised the issue of the window which was to be reinstalled – Cllr Renner-Thompson to contact the site manager.

The meeting was also informed that issues with the first school heating system had meant generators need to be used but it is hoped the problem will be rectified by Spring.
